

I-75 Segment 1


North of Coolidge to North of South Boulevard (3.1 miles)

 North of 13 Mile Road to North of Coolidge Highway (8.6 miles)

8 Mile Road to North of 13 Mile Road (5.5 miles)

Existing Partial Cloverleaf Interchange


- Aging infrastructure
- Outdated roadway geometry




I-75/12 MILE ROAD INTERCHANGE

Proposed Diverging Diamond Interchange (DDI)


- Modern interchange that matches corridor interchanges at I-75/University Drive; I-75/Big Beaver Road; and I-75/14 Mile Road
- Smaller footprint as compared to existing interchange (no additional right-of-way)
- Improved operations and safety with upgraded roadway geometry
- Reduces interchange conflict points as compared to a traditional diamond interchange
- Crash reductions have been observed at other DDI locations in Michigan





Oakland County Water Resource Commission (OCWRC) maintenance access

- Existing at-grade crossing at SB Exit Ramp
- Maintenance vehicles have to cross live traffic on ramp without traffic signal
- Authorized Vehicles only


PROPOSED ACCESS STRUCTURE - EXISTING CROSSING








- Remove existing interchange ramps

2022 Construction Staging


- 12 Mile Road will be closed and detoured to through traffic
- Access to businesses will be maintained at all times
- Pedestrian traffic will be detoured to Bellaire
 Pedestrian Bridge
- Bus routing will be reviewed and mitigated with SMART
- Emergency response routing and will be reviewed and mitigated with the appropriate agencies
- All lanes and ramps will reopen before seasonal shutdown (November to March)



I-75/12 MILE ROAD CONSTRUCTION STAGING

2023 Construction Staging

- 12 Mile Road will be closed and detoured to through traffic for portion of 2023 Construction Season (March to August)
- Access to businesses will be maintained at all times
- Pedestrian traffic will be detoured to Bellaire
 Pedestrian Bridge
- Bus routing will be reviewed and mitigated with SMART
- Emergency response routing and will be reviewed and mitigated with the appropriate agencies
- I-75/12 Mile Road Interchange will be completely open to traffic (Late Summer/Early Fall 2023)



I-75/12 MILE ROAD CONSTRUCTION STAGING

Other Issues

- Night work and associated noise will be minimized and only allowed for essential short term work items such as bridge removal and bridge deck pours
- Air quality and dust control measures will be implemented during construction including regular watering
- Closure and construction updates will be provided to public
